Overview

- Ink Stain Remover for top coated leathers (finished leathers)
- Use this Ink and Stain Remover when an ink or other stain is visible on the surface of the leather, and only use as a stain remover.
- · Not for use on fibrous suede, nubuck, or unfinished leathers

• Ink and Stain Remover for top coated leathers (finished leathers)

Technical Information

Flexiclean IRS-832 removes ink and other stains from top coated leathers (finished leathers).

If possible, remove the stain immediately, before it has the opportunity to set. Allow the Ink Stain Remover to do the work. Do Not rub hard or force the stain into the leather.

Directions for Use

- 1) For fresh stains, remove any excess staining material with a clean, white absorbent cloth prior to using the Ink Stain Remover.
- 2) Always pre-test the Ink Stain Remover in a hidden area. Do Not use this product if any leather color comes off in the pre-test.
- 3) Remove the cap and push the stick up about 1/4 inch, so that the top of the tube does not damage the leather.
- 4) Coat the stained area by rubbing the gel directly on the leather surface
- 5) As the stain transfers to the gel stick, wipe off the end of the gel stick with a clean cloth or tissue to remove stain
- 6) Repeat steps 4 & 5 as needed, to remove the stain

For persistent stains, apply the Ink Stain Remover to the stain and allow to remain on surface for 12-24 hours. Wet the tip of a soft toothbrush with water and gently agitate to create foam. Wipe the leather with a clean, white absorbent cloth. Apply Leather Conditioner Flexicon LC-65 or Protection Cream Thetapel LP-C600 to the area, and blot dry with a white absorbent cloth. Change to a clean cloth when needed. Do not rub hard. Repeat process again, if needed.
